Synopsis of Green Book Movie

The Movie begins with the situation of Copabana, a bar in Bronx New York City where an Italian American bouncer Tony Lip works in 1962. Tony and Dr. Shirley headed north in an attempt to make it home by Christmas Eve but were caught in a blizzard. After being pulled over again, Tony as the driver was arrested by a police officer. They were worried they would get the same treatment as they did before, but when the police turned out to be friendly, they were both surprised and noticed that one of the tires was about to run out. The officer helped them fix a flat tire that they were able to make it home. After arriving home, Tony invited Dr. Shirley to have dinner with his family, but he declined then headed to his place.
