

5.1 Kesimpulan

Berdasarkan hasil dan pembahasan diatas, maka dapat diambil kesimpulan, yaitu: Tidak didapatkan adanya hubungan yang signifikan antara nilai NLR terhadap kesembuhan luka dengan korelasi negative dari NLR terhadap kesembuhan luka. Semakin tinggi nilai NLR maka semakin rendah prognosis kesembuhan suatu luka pada pasien trauma khususnya pasien dengan fraktur terbuka pada tibia begitu pula sebaliknya

5.2 Saran

Penelitian ini diharapkan dapat dijadikan sebagai batu loncatan dan referensi untuk penelitian-penelitian selanjutnya, khususnya mengenai hubungan antara indikator inflamasi lainnya terhadap kesembuhan luka pasien fraktur terbuka .
