

FIVE-YEAR WORK PLAN OF THE AICHR 2021-2025

I. Introduction

Pursuant to the ASEAN Charter, ASEAN Human Rights Declaration (AHRD) and the Phnom Penh Statement on the Adoption of the AHRD, ASEAN Community Vision 2025, and the Terms of Reference (TOR) of the AICHR, this Five-Year Work Plan for the period of 2021 – 2025 includes programmes and activities of the AICHR with indicative budget to be approved by the ASEAN Foreign Ministers Meeting, upon the recommendation of the Committee of Permanent Representatives to ASEAN.

The completion of the Five-Year Work Plan 2016-2020 marks the 10th anniversary of the AICHR, during which the AICHR expanded its programmes and activities to cover a wider range of rights issues in line with ASEAN priorities, as well as highlighted the complementarity of the Sustainable Development Goals with the building of an inclusive ASEAN community. The AICHR has also strengthened its cross-sectoral and cross-pillar cooperation in its efforts to mainstream human rights across the three pillars of ASEAN. Most notably, in the area of rights of persons with disabilities, the AICHR spearheaded the development of the ASEAN Enabling Masterplan 2025: Mainstreaming the Rights of Persons with Disabilities, which was adopted by the ASEAN Leaders in November 2018.

This Five-Year Work Plan will continue the AICHR's work on the promotion and protection of human rights in line with the AHRD and the Phnom Penh Statement on the Adoption of the AHRD, the ASEAN Community Vision 2025, and the TOR of the AICHR. The AICHR will also work to further its engagement with ASEAN Organs, ASEAN Sectoral Bodies/Entities, ASEAN external partners and Civil Society Organisations with consultative relationship with the AICHR on various emerging human rights issues.

II. Principles

The Work Plan of the AICHR, together with all its activities must be in accordance with the principles, mandate, functions and modalities under the ASEAN Charter, AICHR's TOR as well as the AHRD and the Phnom Penh Statement on the Adoption of the AHRD.

Participation by various sectors of society of each ASEAN Member State in the implementation of the Work Plan shall be determined by AICHR, taking into consideration the need to encourage as broad a participation as possible.

III. Vision, Result Areas and Objectives

3.1 Vision

An AICHR that is responsive to the rights of the ASEAN people and promotes regional cooperation in the promotion and protection of human rights, contributing to the realisation of the ASEAN Community Vision 2025.

3.2 Result Areas

- 1. AICHR as an example modality for coordinating human rights rules-based cooperation and activities;
- 2. Regular dialogue on human rights with ASEAN Member States and relevant stakeholders to build confidence in sharing information across member states; and
- 3. ASEAN Member States fulfilling international commitments in line with the principles of the ASEAN Charter.

3.3 Objectives

In accordance with the objectives and principles of the ASEAN Charter and the TOR of the AICHR, the Work Plan aims to further enable the AICHR to:

- 1. To promote and protect human rights and fundamental freedoms of the people of ASEAN;
- 2. To uphold the right of the peoples of ASEAN to live in peace, dignity and prosperity;
- To contribute to the realisation of the purposes of ASEAN as set out in the ASEAN Charter in order to promote stability and harmony in the region, friendship and cooperation among ASEAN Member States, as well as the well-being, livelihood, welfare and participation of ASEAN peoples in the ASEAN Community building process;
- 4. To promote human rights within the regional context, bearing in mind national and regional particularities and mutual respect for different historical, cultural and religious backgrounds, and taking into account the balance between rights and responsibilities;
- 5. To enhance regional cooperation with a view to complementing national and international efforts on the promotion and protection of human rights; and
- 6. To uphold international human rights standards as prescribed by the Universal Declaration of Human Rights, the Vienna Declaration and Programme of Action, and international human rights instruments to which ASEAN Member States are parties.

V. Implementation and Review

The AICHR will ensure the full and effective implementation of the TOR of the AICHR, and contribute to the implementation of the ASEAN Community Vision 2025 and the APSC Blueprint 2025 through relevant mechanisms, efficient mobilisation of resources, effective communication to all stakeholders and regular review and evaluation.

In addition to thematic areas of work as specified in Section IV Work Plan, the AICHR has committed to activities that support the implementation of ASEAN regional frameworks in the areas of trafficking in persons, prevention and counter the rise of radicalisation and violent extremism, protection of the rights of migrant workers, and mainstreaming the rights of persons with disabilities.

When requested by the AMM and relevant ASEAN Sectoral Bodies, the AICHR can also work outside the above-mentioned thematic areas and activities.

5.1 Resources

Funding for this Work Plan and its activities shall be mobilised and allocated in accordance with the ASEAN Charter, the Terms of Reference of the AICHR and the general financial rules and procedures of ASEAN.

5.2 Monitoring and Evaluation

- Annual progress of the implementation of the Five-Year Work Plan 2021-2025 and the annual Work Plans of the AICHR will be reported to the AMM at the annual Interface between the AMM and the AICHR.
- An AICHR Monitoring and Evaluation (M&E) framework and tool will be designed and implemented in 2021.
- Monitoring and evaluation of programmes/activities to implement the Five-Year Work Plan will be measured against its objectives and expected deliverables set for each programme/activity as well as its alignment to the APSC Blueprint 2025.
- A mid-term review of the Five-Year Work Plan 2021-2025 will be conducted in 2023; and a final review of the Five-Year Work Plan 2021-2025 will be conducted in 2025. In the course of the review and evaluation, the AICHR is given the flexibility to update the Priority Areas and Indicative Activities of the Five-Year Work Plan as well as to adjust its implementation strategy to be reflected in the annual Work Plans of the AICHR.
