

Samuel Langhone Clemens (born 30 November 1835 - died April 21, 1910 at the age of 74), better known by his pen name Mark Twain, was an American novelist, writer, and teacher. Some of his most famous works are The Adventures of Huckleberry Finn, The Adventures of Tom Sawyer, The Prince and the Pauper, A Connecticut Yankee in King Arthur's Court and one of his nonfiction books, Life on the Mississippi. Mark Twain was born in 1835. He grew up in Hannibal, Missouri, a small town on the Mississippi River in the United States. As a teenager he was very attracted to the steamboats that roamed the great river of the United States. When he was very young, Twain was already working as a printmaker at a printery, and occasionally as a newspaper writer. As a teenager, he was a river ship captain and spent four years sailing on the Mississippi River. When the American Civil War broke out in 1860, Mark moved to the west in California.
