A. Kesimpulan

1. Rerata waktu pulih pasien di ruang pulih sadar instalasi bedah sentral RSUP Dr. Wahidin Sudirohusodo pada pasien dengan status fisik pra GA ASA I adalah 42,3 menit.
2. Rerata waktu pulih pasien di ruang pulih sadar instalasi bedah sentral RSUP Dr. Wahidin Sudirohusodo pada pasien dengan status fisik pra GA ASA II adalah 50,6 menit
3. Secara statistik tidak terdapat perbedaan bermakna antara waktu pulih pasien dengan status fisik pra GA ASA I dan waktu pulih pasien dengan status fisik pra GA ASA II

B. Saran

1. Perlu diadakan penelitian lebih lanjut dengan jumlah sampel yang lebih besar.
2. Perlu diadakan penelitian lebih lanjut dengan membandingkan status fisik pra anestesi yang berbeda.
