- e. Hasil penelitian nilai tukar berpengaruh secara signifikan terhadap ekspor dalam mendorong pertumbuhan ekonomi. Semakin stabil nilai tukar akan mendorong pertumbuhan ekonomi melalui ekspor.

6.2 SARAN

Berdasarkan hasil penelitian dan kesimpulan maka saran dari penulis yang bisa dikemukakan antara lain:

- a. Pemerintah daerah Provinsi Sulawesi Selatan hendaknya fokus pada komoditi ekspor yang memiliki daya saing dan daya penetrasi pasar yang kuat.
- b. Kebijakan dalam menjaga nilai tukar pada level yang tepat merupakan kebijakan yang perlu dilakukan pemerintah agar volume ekspor meningkat sehingga mendorong pertumbuhan ekonomi.
