Hard work, consistency and integrity have led him to become a capable academic as well as a politician. He also received an honor beyond his expectations: becoming Minister of Law and Human Rights for two terms in the Jokowi

administration and was appointed Professor of Criminology at the College of Police Science (STIK).

Cheers really rumbled across most Nias people, when on 27 October 2014, President Jokowi announced the name Yasona Hamonangan Laoly as Minister of Law and Human Rights. For Nias people, this is a rare event. It could be an opportunity only once. There is so much pride. Understandably, throughout the history of the Republic of Indonesia, it was the first time a Nias son became a minister! People with Nias ethnic background - often referred to as Ono Niha - feel that their head is also pinned with a shiny gold crown.

Ono Niha can. Ono Niha was appreciated. This is history! And, that history was inscribed by a Yasonna Hamonangan Laoly. This is the highest achievement in the government sector among Nias people. Of course, such a proud achievement did not just happen. This is one of the results of a series of Yasonna's life struggles, which are not only hard, but consistent and full of values as a capable academic as well as a politician. It is not surprising that he received an honor beyond his expectations: Becoming Minister of Law and Human Rights in the Jokowi Administration for the 2014-2019 Period.

In the cabinet, which was named the Working Cabinet, Yasonna later succeeded in showing hard work, consistency and integrity through various achievements, breakthroughs and breakthroughs. As a result, when Jokowi was re-

elected as president for the second time, Yasonna was again appointed as The Minister of Human Right in the Advanced Indonesia Cabinet.

In addition, President Jokowi also gave him a special task to handle the omnibus law. Omnibus Law is a law made to target big issues in a country. Usually the making of this law is carried out by revising or repealing the existing law.

Interestingly, when the second time he was elected as Minister of law and human right, Yasonna had actually successfully walked as a people's representative from the PDIP faction in the DPR-RI for the 2019-2024 period, even being inaugurated on October 1, 2019. But finally he resigned as a member of the DPR and chose to serve as minister.

Nias-Batak "crossbreed"

The name 'Yasonna Hamonangan Laoly' may sound a little strange to the ear, especially for people outside North Sumatra Province, because this name combines elements of Batak and Nias languages.

The name 'Yasonna' is taken from the Nias language 'Yaso Nasa', meaning 'there is more'. His father hoped that after Yasonna's birth, there would be more of Yasonna's siblings who would be born. Meanwhile, 'Hamonangan' in Batak language means 'victory'. And 'Laoly' is one of the clans in Nias society.

Yes, this man who was born on May 27, 1953 did inherit genes from two different ethnicities, namely a Nias tribe named F. Laoly and a Batak mother named R. Sihite. It could be, this factor is what makes him grow up as a handsome and smart boy.

His father had a police background, with the last rank of major. Then he became a member of the Sibolga City parliamant and a member of the Central Tapanuli parliament from the ABRI faction.

The first child of six children was born in Sorkam-Tapanuli Tengah. When he was two years old, his family moved to Barus-Tapanuli Tengah. Several years later, he moved again to Sibolga City. It was in Sibolga that Yasonna spent his childhood and adolescence.

"In Sibolga, initially we lived in a rented house, but then around the 1960s, we were allowed to live in the Sambas Sibolga Police Dormitory. Soon the parents were finally able to build their own house, "he said.

The house on Jalan Jati Number 34, Pancuran Kerambil Village, Sibolga
Sambas District is still standing strong, but still simple, as it used to be. There,
Yasonna's parents raised their six children.

Yasonna's childhood was running normally like other children. Playing with peers has become a daily routine. In view of his brother, Yasonna is a good man, diligent, and responsible for guiding his younger siblings.

"He is a good brother in building a family, especially for us, his younger siblings. He is also a man who has a firm and disciplined attitude, "explained his fifth brother, Imanuel Laoly, one day.

There is one childhood memory that he will never forget, namely the hard struggle of both parents in supporting their families and helping others. Because his salary as a police officer was not sufficient for his daily needs, his father tried to earn extra money by trading cooking oil during his duties.

The father bought cooking oil at the trade shop owned by his brother Ama
Ya'aro Laoly in Medan, and then sold it again in Sibolga.

"I rode a bicycle with my father, carrying an empty oil can for me to eat
