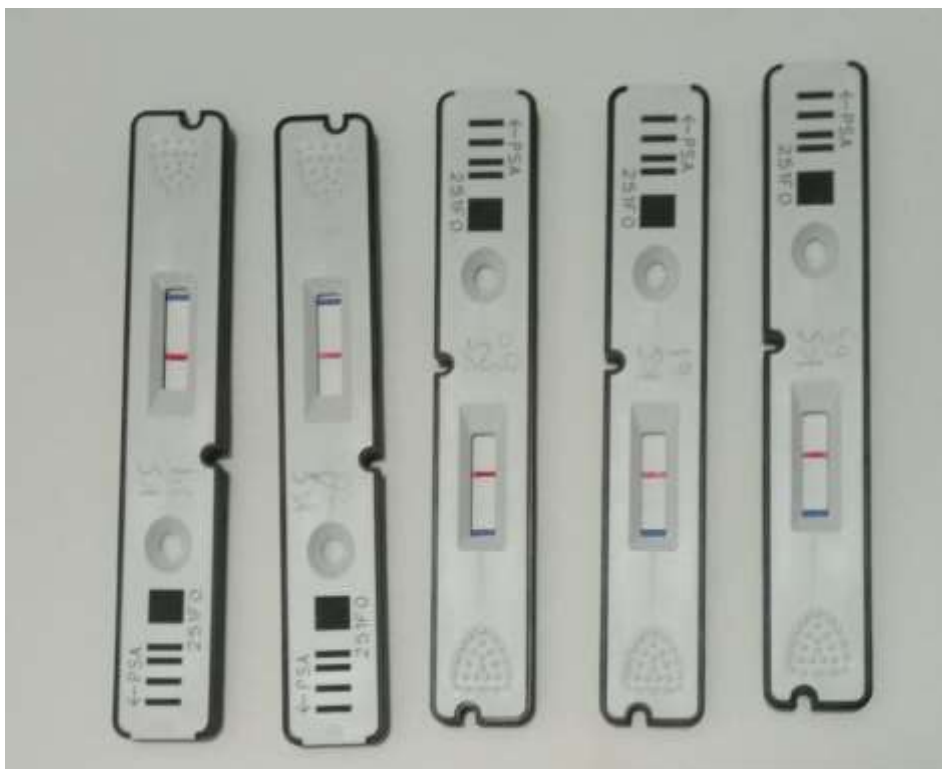


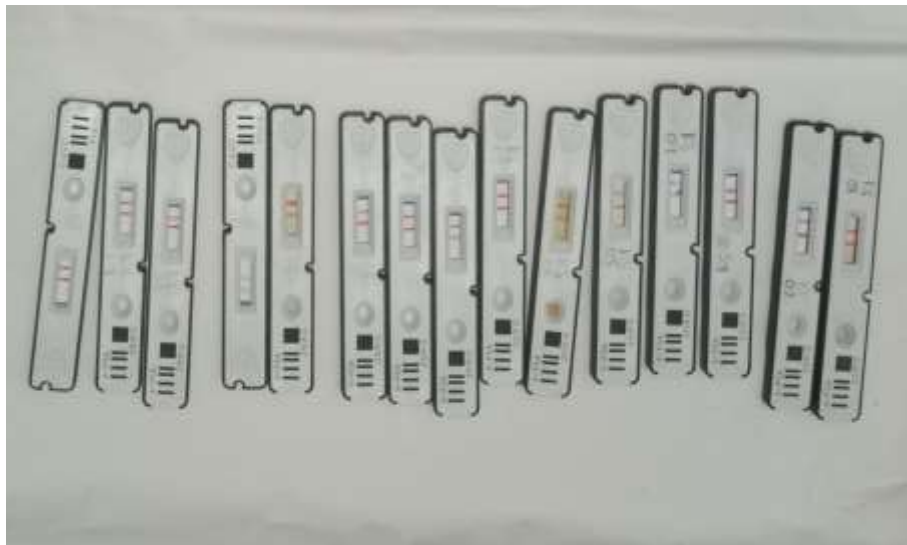

HASIL PSA NEGATIF



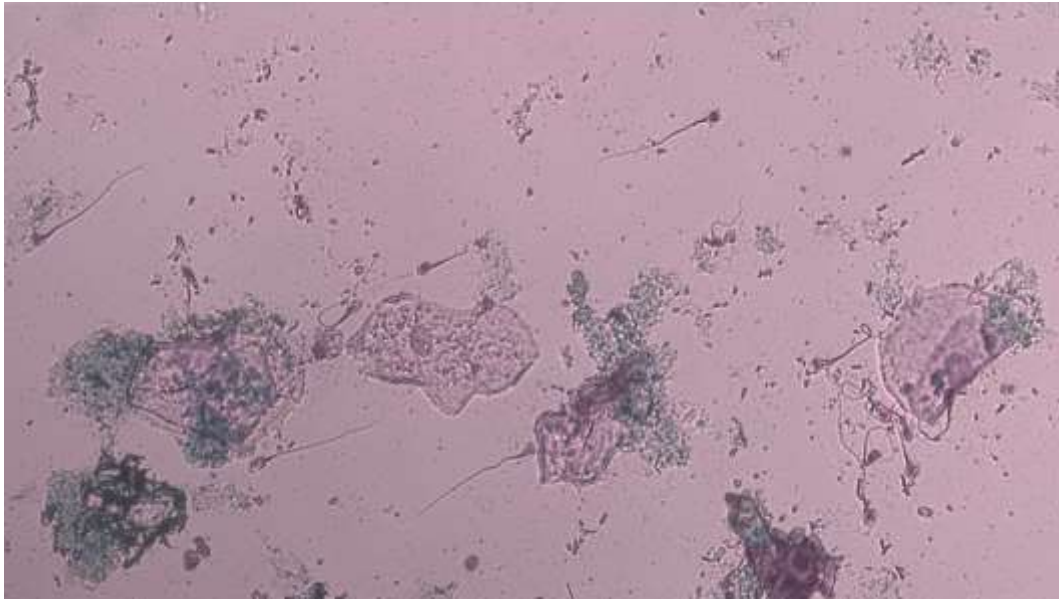

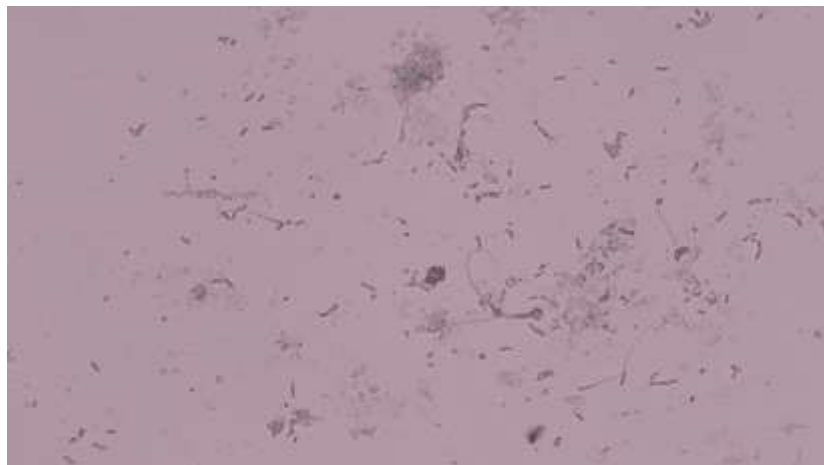
