

2. The Biography of Cormac McCarthy



Cormac McCarthy was born on July 20, 1933, Providence, Rhode Island, United States and died on June 13, 2023, Santa Fe, New Mexico, known as a reclusive person who dislikes fame. An American author, McCarthy's novels about the

mischievous characters of the rural American South and Southwest are notable for their dark violence, solid prose, and complexity.

McCarthy spent much his life in Tennessee, and his early works are clearly influenced by that region. His first four published novels, *The Orchard Keeper* (1965), Outer Dark (1968), Child of God (1973), reflect the culture, myth and character of East Tennessee and Appalachia.

McCarthy was raised as a Catholic. She went to church regularly and had attended a Catholic high school. Then, in 1951, he registered at the University of Tennessee. However, he had only completed one year of college when he decided to enlist in the US Air Force. He spent four years in the military, two of which were in Alaska, before returning to the University of Tennessee in 1957, where he slowly became interested in fiction writing. After publishing two stories in the campus literary magazine, The Phoenix, he won grants from the Ingram-Merrill Foundation for creative writing in 1959 and 1960. Convinced of his potential, Cormac McCarthy left university in 1960 to pursue his writing career full-time.
