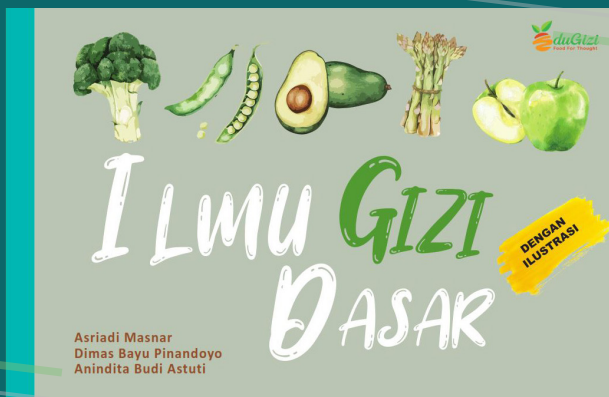
Andi Imam Arundhana Thahir
